RECOMMENDATION:

Adopt Resolution of the City Council of the City of Livingston Accepting Certification of the Election Results of the Special Recall Election of August 31, 2010, Reciting the Election Facts, and Directing the City Clerk to Administer Oaths of Office to the Mayor-Elect and Council Member-Elect.

BACKGROUND/DISCUSSION:

On August 31, 2010, a special recall election was held for the recall of Mayor Daniel Varela, Sr., and Council Member Martha Nateras. Based on the tabulations from the Merced County Clerk-Registrar of Voters there were a sufficient number of votes to recall Mayor Varela and Council Member Nateras. The tabulation of the votes also indicates that Council Member Rodrigo Espinoza will succeed Mayor Daniel Varela, Sr., as the Mayor, and that Theresa Land will succeed Council Member Nateras as Council Member for the remainder of their terms. A copy of the certification of the election results from the Merced County Clerk-Registrar of Voters is attached.

FISCAL IMPACT:

The City is responsible for the costs of the special election. The City has not yet received a final bill from the County for the cost of the election. The costs of the election were previously estimated by the County at \$54,000.

RESOLUTION NO. 2010-

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LIVINGSTON ACCEPTING CERTIFICATION OF THE ELECTION RESULTS OF THE SPECIAL RECALL ELECTION OF AUGUST 31, 2010, RECITING THE ELECTION FACTS, AND DIRECTING THE CITY CLERK TO ADMINISTER OATHS OF OFFICE TO THE MAYOR-ELECT AND COUNCIL MEMBER-ELECT

WHEREAS, a special election was held and conducted in the City of Livingston, California, on Tuesday, August 31, 2010 (the "Special Election"), pursuant to applicable law; and

WHEREAS, the Merced County Clerk-Registrar of Voters executed a certification of the results of the canvass of the Special Election (the "Certificate of Election"), a true and correct copy of which is attached hereto as Exhibit A and incorporated herein by reference, and which was delivered to the City on or about September 10, 2010.

NOW, THEREFORE, BE IT RESOLVED by the City Council that:

- 1. The City Council adopts and incorporates by reference the Registrar's Certificate of Election results attached hereto as Exhibit A, and incorporated herein by reference, reciting the facts of the election including: (a) the whole number of votes cast in the City; (b) the names of the persons voted for; (c) the measures voted upon; (d) what offices each person was voted for; (e) the number of votes given at each precinct to each person and for and against each measure; and (f) the number of votes given in the City to each person and for and against each measure.
- 2. The City Council declares and determines the results of the Special Election as follows: Mayor Daniel Varela, Sr., and Council Member Martha Nateras are recalled from the offices of Mayor and Council Member, respectively. Council Member Rodrigo Espinoza is elected as Mayor to succeed Mayor Daniel Varela, Sr., for the remainder of his term. Theresa Land is elected as Council Member to succeed Council Member Martha Nateras for the remainder of her term.
- 3. The City Clerk is authorized and directed to deliver to each of the persons so elected a copy of the Certificate of Election by the Merced County Clerk-Registrar of Voters and to administer to each person so elected the oath of office prescribed in the Constitution of the State of California, after which they shall be installed as the newly elected officers.
