EXECUTIVE SUMMARY

Background & Philosophy

The owners and management of Gilton Solid Waste Management, Inc. (GSWM) are excited with the potential opportunity to continue and expand our services to the residents, businesses and industries within the City of Livingston. Since 1947, the Gilton family has continuously provided reliable, high quality waste management services to communities throughout the central valley of California. We welcome the chance to once again show that we can not only meet, but exceed all of our customer's expectations.

GSWM is uniquely qualified and positioned to provide the most cost-effective, fully integrated waste collection, processing, recycling and waste transfer services for all those living and working in Livingston. As we have proven in the past, GSWM's ability to efficiently and effectively spread our equipment, labor and management costs over multiple jurisdictions has <u>routinely resulted in the lowest costs to our customers</u>. The second cart would be for green wastes, cardboard, paper products and vegetative compostable materials.

GSWM uses this <u>highly effective</u>, <u>cost efficient program in five (5) other jurisdictions</u> that we serve. This system has allowed us to significantly increase the weight and percentage of residential waste diversion in each of these communities. **Details of the program are outlined in Attachment "H**".

On the other hand, should the City decide at some point in this process to stay with the existing one container program, we have prepared optional rates for that type of program for the City to consider (see Attachment "C").

GSWM respects our competitors in this bid process, yet we are confident that the City of Livingston will select GSWM to continue our long term partnership in serving the residents, businesses and industries in the community. But regardless of the words and numbers that follow, we are proud to know that GSWM is known for its 65 years of dependable collection systems, excellent customer relations and diligent, high quality service to all our customers.

EXCEPTIONS TO DRAFT CONTRACT

Page 5, Recyclable Materials: "The City shall be given credit for all recyclables collected, less any contaminants, and be given all net revenues based on market price per ton of Recyclable Materials."

Page 6, Roll-Off Container: "... means a metal container with a capacity of twenty (20) ten (10) or more or cubic yards...."

Page 8, Reports and Audits: The Contractor is entering into a legal agreement with the City of Livingston only. The Merced County Solid Waste Authority is not a signatory to the contract, therefore - "Contractor shall provide such monthly, annual, and other reports as the City and/or the Merced County Solid Waste Management Authority ("Authority") shall require. Contractor shall cooperate with and allow the City and/or Authority to conduct waste flow audits and performance reviews as are deemed necessary, in the sole discretion of the City or Authority. Said reports, audits, and performance reviews shall be undertaken and completed at the expense of the Contractor."

Page 14, Clean Up: "During the Collection and transportation process, Contractor shall clean up Litter in the immediate vicinity of any Solid Waste storage area (including the area where Collection Bins and Debris Boxes are delivered for Collection) whether or not if Contractor has caused the Litter. Contractor shall discuss instances of repeated spillage with the Waste Generator responsible and will report such instances to City. The City will attempt to rectify such situations with the Waste Generator if Contractor has already attempted to do so without success."

Page 22, Exhibit A, Garbage Cart Specifications –

- "Carts: 90 gallons
 - Manufacturer: Toter, Rehris Pacific, er OHO, or any equivalent as determined by the City Public Works Director."


