Dear Deputy City Clerk,

Please find enclosed the technical and cost proposal from Sunset Waste Systems (Sunset) to provide solid waste collection, recycling, and disposal services. The goal of the Request for Proposal (RFP) process is to obtain cost-effective, quality service for the City of Livingston's (City) residents and businesses. In doing so, the City is looking for a service provider who can deliver efficient service while meeting the recycling and diversion targets set by the City, state, and federal government. Sunset is a highly skilled, efficient, and reliable provider of refuse and recycling services that fit the requirements of the City.

We are proposing to perform all collection, transfer, processing and disposal components. Our firm is full service and one of the most dynamic and advanced in waste systems and recycling in California; and we are fully capable to supply all of the services needed under this RFP as we demonstrate within.
