## 2015 Ford Explorer Police Vehicles



- Effective January 1, 2015
- Must pass DMV rules of the road test
- Prohibits Law Enforcement from using for investigations or detention based on immigration status
- Proposed Regulations and Current Examples of Documents
  - □ (one form) Mexican Federal Electoral Card
  - (two forms) Guatemalan National ID card and Peruvian ID card or one valid Consular Card
  - □ (two forms) Expired Foreign Passport, National Civil Registry birth certificate or federal government ID card



- If applicant is unable to meet of the previous requirements, then a DMV investigator can attempt to verify applicants identity through:
  - □ Official school Transcripts
  - Applications for Asylum
  - Student Eligibility Certificate
  - ☐ Marriage License
  - □ Divorce Decree
  - □ Foreign Drivers License
  - Income Tax Return
  - Other approved documents

- Deeds or Titles to Residential Property
- Mortgage Bills
- Home Utility Bills
- School Records
- Medical Records
- IRS or California Tax Returns
- DMV titles
